## Conditions for the Grant of Contractor's Licence Class 'B'

(a) Licence may be granted only to a person or a firm having a Registered Office in Kerala, (unless exempted from this requirement by the Board.)

(b) Fees

- 1. Cost of Application Form : Rs. 500
- 2. Initial fee to be sent along with application : Rs. 500
- 3. Fee for issue of licence after verification : Rs. 5000
- 4. Cost of Staff Register Rs. 300.

The fee should be paid by means of chalan under the head of account "0043-00-800-99" remitted at any Govt. Treasury or through Janasevanakendram in favour of the Secretary, Kerala State Electricity Licensing Board, Thiruvananthapuram. No other mode of remittance is permitted. The fee once remitted into the treasury will not be refunded or adjusted against any other purpose.

(c) Nature of work :

To carry out Low Voltage or Low Voltage and Medium Voltage electrical installation work of a specified capacity in the consumer's premises. The Board however reserves the right to reduce or enhance this limit if found necessary subsequently.

(d) Establishment :

The applicant shall employ solely for the purpose of contract works the following minimum of staff on full time basis.

- (1) One Supervisor holding Supervisory Permit Grade 'B' issued by the Kerala State Electricity Licensing Board.
- (2) Two wiremen upto 50 kW, three wiremen for 150 kW, four wiremen for 250 kW holding wiremen permits granted by the Kerala State Electricity Licensing Board.

(e) The applicant shall possess the following instruments :

- 1. One number 500 V megger (1000 V Megger also required for the scope above 50 kW)
- 2. One number Earth Tester.
- 3. Tong Tester - 100 A
- Tong Tester 600 A 4.
- One number Neon testers & Multimeter 5.
- All Wiring Tools. 6.

The instruments shall be tested initially before the issue of licence and as specified intervals thereafter at the Meter Testing and Standards Laboratory attached to the Electrical Inspectorate, Thiruvananthapuram or such laboratory specified by the Board and the test report produced before the Licensing Board for perusal and return.

(f) Production units or manufacturing concerns should segregate the staff employed for the purpose of contractors licence from the staff engaged for routine operations of the factories. The staff employed under the Licensing Board Rules and under rule 45 of the Indian Electricity Rules shall not on any account be mixed up. Failure to keep separate staff for the purpose of the Licensing Board Rules and rule 45 of the Indian Electricity Rules shall be deemed to be violation of the rules and shall render the licence liable for cancellation.

(g) Change of Name :- No Change in the name and style of the Contractors Licence is permissible. A Contractors Licence issued to a partnership firm shall stand cancelled immediately, if there is any change in the partnership.
