3. As Per The Noise Pollution (Regulation and Control) Rules 2000, the sound level allowed is limited to the following

- 4- **Use of loudspeaker is Prohibited.**
 - Between 2200 hrs and 0600 hrs.
 - On a moving vehicle.
- 5- Placement of loudspeaker should not be changed from that stated in this application without obtaining Prior Permission from the Police.
- 6- If terms and conditions as stated in this Permit are abused, loudspeaker contractor will be prosecuted under Section 131 of the Bombay Police Act 1951.
- 7- As Per Section 15 of the Environment (Protection) Act of 1986 violation of any of the Provision of the Environment (Protection) Act of 1986 or any order/rules thereunder will result in a jail term of 5 years and a fine of Rs. 1,00,000 (Rs. 1 Lakh).
